RULES FOR USING THE KIDS' SUMMER PARK

1. Tickets and Access

- Every visitor must have a valid ticket to enter the Park.
- Users are required to show a fiscal receipt to the Kids' Park staff upon request at any time.
- Pregnant women, children under 4 years old, persons with heart conditions, and persons with serious injuries are not allowed to use the Park.
- It is forbidden to use the Park's facilities under the influence of alcohol or other intoxicating substances.
- Conditions on the tracks may vary; visitors need to consult with our staff before purchasing tickets.

2. Footwear and Clothing

- Closed footwear is mandatory for participating in the Park's activities; long-sleeved clothing and long pants are recommended.

3. Safety and Instructions

- All visitors must follow the instructions of the Kids' Park staff.
- Children aged 4 to 12 must be supervised by a guardian who is responsible for them during their stay in the Kids' Park.
- The Kids' Park staff are not responsible for supervising children; the parent or adult guardian is responsible.

4. Rules of Use

- The use of sliding devices other than those provided by the Park is strictly prohibited.
- It is forbidden to climb over the fence around the Kids' Park, as well as to use any entrances or exits other than the designated ones.
- Pushing, rushing, jumping, or walking on the tracks, as well as any other inappropriate behavior that may endanger the safety of users, is prohibited.
- Every user must use appropriate equipment when using the facilities in the Kids' Park, as prescribed by the instructions for using the Park's facilities.

5. Other Rules

- It is prohibited to damage property in the Kids' Park, as well as to disturb other users and staff within the Park.
- Any violent or inappropriate behavior is not allowed in the Kids' Park. If a staff member identifies such behavior, the user will be removed and banned from re-entering the Kids' Park.
- Any damage caused or noticed by a user must be reported to the Kids' Park staff.
- Unsafe and irresponsible behavior may result in the removal of the user without a refund.
- There are no refunds after ticket purchase.
